**PERMIT TO SELL REFRESHMENTS ADJACENT TO A CITY PARK**

The undersigned hereby makes application for permission to sell refreshments (prepared food, snacks, non-alcoholic beverages, etc.) on City streets adjacent to a City park for the period indicated below, expressly agreeing that such use shall be subject to Article II, Chapter 4, of Title XII of the Modesto Municipal Code (Sections 12-4-.201 and 12-4.202) and the following terms, conditions and regulations:

1. Prior to approval by the Director of the Parks, Recreation & Neighborhoods Department, applicant must present a permit, issued by the Modesto Fire Department, certifying that the applicant's vehicle and any other essentials equipment, fuels, etc., are in compliance with any applicable Fire Codes.
2. The undersigned certifies that the applicant has obtained insurance that will indemnify and hold the City of Modesto harmless from any and all claims, loss or damage to any person or persons, or to property of any kind whether or not belonging to the undersigned, arising out of or in any way related to the activities of the Permittee.
3. This permit shall be issued with the understanding that the applicant is not given exclusive permission to sell at any particular location or adjacent to any specific park or any City street.
4. Selling of any products on park property, including parking lots, is expressly prohibited.
5. No portion of the vendor's cart, vehicle, person or related items shall obstruct the sidewalk or extend onto park property. To the extent possible, applicant shall endeavor to keep groups of patrons and customers from obstructing rights of way and park access.
6. The applicant shall be responsible for obtaining any and all other permits as shall be required and hereby agrees to operate permit in full compliance with all applicable local, state and federal laws and regulations.
7. Removal of any and all litter and debris resulting from sales of the applicant's products shall be the responsibility of the applicant.
8. The City of Modesto prohibits discrimination on the basis of race, religion, creed, sex, color, national origin, or handicap. (Federal Civil Rights Acts of 1964, Title III, California Civil Code, Section 51).
